Keep people away, warn other traffic. Check for spills, leaks. Tanker/Vehicle Call the Emergency Services: Dial 111. Accident Spill or leak Wear overalls, chemical resistant gloves, full frame goggles and dust mask. Prevent further spillage. If possible salvage uncontaminated product. Shovel or sweep up spilled material and place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in same sealable container as spilled material. Seek advice from the local authority regarding disposal. Call the Fire Service: Dial 111. Wear protective clothing and self-contained breathing apparatus. During a fire toxic Fire fumes may be released. Extinguish fires with water spray, foam, dry powder or CO₂. Keep containers cool by spraying with water if exposed to fire. Contain run-off. Keep non-involved persons away. **FIRST AID** Do NOT induce vomiting. Rinse mouth. For advice contact the National Poisons Centre 0800 POISONS (0800 764 If Swallowed: 766) or a doctor. If in Eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists, get medical advice/attention. If on Skin: Remove contaminated clothing and flush skin and hair with soap and running water. Do NOT scrub the skin. If skin irritation or rash occurs, get medical advice/attention. If Inhaled: Remove to fresh air and keep at rest in a position comfortable for breathing. If experiencing respiratory symptoms get medical advice/attention STORAGE AND SEGREGATION Storage: Store in original container, tightly closed, in a cool, well ventilated area away from food, feedstuffs, animals, or fertilisers. Keep away from heat. Protect from direct sunlight. Avoid temperatures below -5°C and above 30°C.
