IF THIS HAPPENS DO THIS															
Tanker/Vehicle Accident		Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the Emergency Services: Dial 111.													
Spill or leak	Wear overalls, chemical resistant gloves, facemask or goggles. Prevent further spillage. If possible salvage uncontaminated product. Absorb spilled material and place in sealable container for disposal. Wash down affected are with water plus detergent. Absorb and collect washings and place in same sealable container as spilled material. Seek advice from the local authority regarding disposal.														
Fire		<b>Call the Fire Service: Dial 111.</b> Wear protective clothing and self-contained breathing apparatus. During a fire toxic fumes may be released. Extinguish fires with water spray, foam or dry powder. Cool sealed containers with water to prevent rupture and explosion due to thermal expansion. Contain run-off. Keep non-involved persons away.
