Spill or leak	uncontai containe	Wear overalls, chemical resistant gloves, facemask or goggles. Prevent further spillage. If possible salvage uncontaminated product. Take up spilled material with a suitable absorbent (e.g. vermiculite) and place in sealable container marked for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in same sealable container as spilled material. Seek advice from the local authority regarding disposal.											
Fire	fog, foar	Call the Fire Service: Dial 111 . Wear protective clothing and self-contained breathing apparatus. Extinguish with water fog, foam, CO ₂ or dry extinguishing media. During a fire toxic fumes may be released. Contain run-off. Keep non-involved persons away.											
FIRST AID													
If Swallowed:		Do NOT induce vomiting. Rinse mouth. For advice contact the National Poisons Centre 0800 POISONS (0800 764 766) or a doctor.											
If in Eyes:	Rinse ca	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.											
If on Skin:		Remove contaminated clothing and wash with plenty of soap and water. Do NOT scrub the skin.											
If Inhaled: Remove to fresh air and keep at rest in a position comfortable for breathing. Get medical advice/attention if you feel unwell.													
STORAGE AND SEGREGATION													
Storage: Store in original container, tightly closed, in a dry, cool, well-ventilated place away from food and animal feeds. Avoid temperatures below 5°C and above 40°C.
