| IF THIS HAPPENS                | DO THIS  |
|--------------------------------|--|
| <b>Tanker/Vehicle Accident</b> | Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks.<br><b>Call the Emergency Services: Dial 111.</b>  |
| <b>Spill or leak</b>           | Wear overalls, suitable gloves, goggles and dust mask. Prevent further spillage. If possible salvage uncontaminated product. Shovel or sweep up spilled material and place in sealable container for disposal. Avoid raising dust. Wash down affected area with water plus detergent. Absorb and collect washings and place in same sealable container as spilled material. Seek advice from the local authority regarding disposal. |
| <b>Fire</b>                    | <b>Call the Fire Service: Dial 111.</b> Wear protective clothing and breathing apparatus. During a fire toxic fumes may be released. Extinguish fires with water fog, foam, dry powder or carbon dioxide. Contain run-off. Keep non-involved persons away.   |

**FIRST AID**

| <b>If Swallowed:</b> | Do NOT induce vomiting. Rinse mouth. <b>For advice contact the National Poisons Centre 0800 POISONS (0800 764 766) or a doctor.</b>   |
| <b>If in Eyes:</b>   | Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists, get medical advice/attention.                            |
| <b>If on Skin:</b>   | If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Do NOT scrub the skin. Wash clothing before reuse. If irritation persists get medical attention. |
| <b>If Inhaled:</b>   | Remove to fresh air and keep at rest in a position comfortable for breathing.   |

**STORAGE AND SEGREGATION**

**Storage:** Store in original container, tightly closed, in a cool, well ventilated area out of direct sunlight and away from food, feedstuffs and seed.

**AGGREGATE STORAGE VOLUME THRESHOLDS:** When stored with substances of the same hazard the aggregate quantity must be considered. For full details refer to the current standard NZS8409 Management of Agrichemicals or the HSNO Regulations.
