Keep people away, warn other traffic. Check for spills, leaks. Accident Call the Emergency Services: Dial 111. Spill or leak Wear overalls, chemical resistant gloves, facemask or goggles. Prevent further spillage. Take up spilled product with a suitable absorbent. Place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container. Seek advice from the local authority regarding disposal. Fire Call the Fire Service: Dial 111. Wear protective clothing and breathing apparatus. During a fire toxic fumes may be released. Extinguish fires with water fog or foam. Cool sealed packs with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away. FIRST AID If Swallowed: Do NOT induce vomiting. Rinse mouth. For advice contact the National Poisons Centre 0800 POISONS (0800 764 766) or a doctor. If in Eves: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists, get medical advice/attention. If on Skin: Remove contaminated clothing and wash skin with soap and water. Do NOT scrub the skin. Wash clothing before reuse. If irritation persists get medical attention. If Inhaled: Remove to fresh air and keep at rest in a position comfortable for breathing. STORAGE AND SEGREGATION Storage: Store in original container, tightly closed, in a cool, well ventilated area out of direct sunlight. Keep and away from food, feedstuffs, animals and fertilisers.
