## EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 944 955

IF THIS HAPPENS	DO THIS
<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills. <b>Call the Emergency Services: Dial 111.</b>
<b>Spill or leak</b>	Wear overalls, chemical resistant gloves and dust mask. Prevent further spillage. Sweep up spilled product and place in sealable container for disposal. Avoid raising dust. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.
<b>Fire</b>	<b>Call the Fire Service: Dial 111.</b> Wear protective clothing and breathing apparatus. During a fire, toxic fumes may be released. Extinguish warehouse fires with water spray, dry powder, CO <sub>2</sub> or foam. Contain run-off. Keep non-involved persons away.

## FIRST AID

<b>If Swallowed:</b>	Do NOT induce vomiting. For advice contact the <b>National Poisons Centre 0800 POISONS (0800 764 766)</b> or a doctor.
<b>If in Eyes:</b>	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
<b>If on Skin:</b>	Remove contaminated clothing and wash skin with plenty of soap and water. Do NOT scrub the skin. Wash clothing before reuse.
<b>If Inhaled:</b>	Remove to fresh air and keep at rest in a position comfortable for breathing. Get medical advice/attention if you feel unwell.

## STORAGE AND SEGREGATION

**Storage:** Store in the closed, original container, out of direct sunlight in a locked-up, dry, well-ventilated area, building or room, as cool as possible, away from children, animals, feed or foodstuffs.

**AGGREGATE STORAGE VOLUME THRESHOLDS:** When stored with substances of the same hazard the aggregate quantity must be considered. For full details refer to the current standard NZS8409 Management of Agrichemicals or the HSNO Regulations.

Refer to NZS5433 Sea Segregation for details.
